

Results of US Court-Martials for August 2015

On 7 August 2015, at a General Court-Martial, SPC Immanuel Martinez, Iron Battalion, 210th Field Artillery Brigade, 2nd Infantry Division, was found guilty of one specification of attempt to commit sexual assault (Article 80, UCMJ), one specification of conspiracy to commit indecent viewing (Article 81), one specification of indecent viewing (Article 120c), three specifications of sexual assault (Article 120), and one specification of abusive sexual contact (Article 120). He was sentenced to be reduced to E-1, to forfeit all pay and allowances, to be confined for 15 years, and to receive a Dishonorable Discharge.

On 14 August 2015, at a Summary Court-Martial, Sergeant (E-5) Brandon G. Nance, United States Army Garrison-Daegu, was found guilty of one specification of Adultery (Article 134, UCMJ) and two specifications of Failure to Obey a Lawful General Order (Article 92). He was sentenced to be reduced to the grade of E-4; to forfeit \$1,634.00 per month for one month; and to be restricted for two (2) months.

On 20 August 2015, at a Special Court-Martial, PV2 Cody Spence, 2-1 ADA Battalion, 35th Air Defense Artillery Brigade, was found guilty of five specifications of Abusive Sexual Contact (Article 120, UCMJ); one specification of Attempted Abusive Sexual Contact (Article 80); two specifications of Assault Consummated by a Battery (Article 128); and one specification False Imprisonment (Article 134). He was sentenced to be confined for 15 days and to forfeit \$386.00.

On 26 August 2015, at a General Court-Martial, PV2 Robier Ramon, 1st ABCT, 2ID, was found guilty of three specifications of Assault Consummated by a Battery (Article 128, UCMJ), and one specification of Violating a Lawful General Regulation (under-age drinking, Article 92). He was sentenced to be reduced to the grade of E-1, to be confined for 30 months, and to receive a Bad Conduct Discharge.

Results of ROK Criminal Prosecutions for August 2015

In Suwon District Court on 24 August 2015, SrA David M. Bartels, 51st LRS, Osan Air Base, was convicted of a violation of the Act on the Punishment of the Acts of Arranging Sexual Traffic. His adjudged sentence was a 300,000 Won fine.

In Suwon District Court on 24 August 2015, PVT Dealonte M. Bibbs, 142d MP Company, USAG Yongsan, was convicted of Larceny and Assault. His adjudged sentence was a 1,500,000 Won fine.

In Uijeongbu District Court on 25 August 2015, SPC Gabriel E. McCastler, HHB, 210th FA Brigade, USAG Casey (Hovey), was convicted of Infliction of Bodily Injury. His adjudged sentence was a 3,000,000 Won fine.

In Seoul Central District Court, on 27 August 2015, SGT Raison D. Delacruz, A Co, 532d MI Battalion, USAG Yongsan, was convicted of Infliction of Bodily Injury. His adjudged sentence was a 1,000,000 Won fine.

In Seoul Central District Court, on 27 August 2015, SGT Ashley N. Dixon, STB, USFK, USAG Yongsan, was convicted of Infliction of Bodily Injury. Her adjudged sentence was a 2,000,000 Won fine.

In Seoul Central District Court, on 27 August 2015, PVT Ryan A. Rapanot, 5th Medical Detachment, USAG Yongsan, was convicted of Infliction of Bodily Injury. His adjudged sentence was a 1,000,000 Won fine.

In Seoul Central District Court, on 27 August 2015, CPT Dequan B. Jones, A Co, 121st CS Hospital, USAG Yongsan, was convicted of DUI. His adjudged sentence was a 3,500,000 Won fine.
