

Results of US Court-Martials for December 2015

On 2 December 2015, at a General Court-Martial, Staff Sergeant Hector Nicola, Iron Battalion, 210th Field Artillery Brigade, was found guilty of one Specification of failure to obey a lawful general order (Article 92, UCMJ), one Specification of abusive sexual contact (Article 120), and one Specification of indecent viewing (Article 120). He was sentenced to be reduced to E-1 and to be discharged with a Bad Conduct Discharge.

On 10 December 2015, at a Summary Court-Martial, PV2 Keena Watts-Torres, 15th Brigade Support Battalion, 2d Armored Brigade Combat Team, was found guilty of one Specification of disrespect towards a superior commissioned officer (Article 89, UCMJ), two Specifications of failure to obey a lawful general order (Article 92), and one Specification of false official statement (Article 107). She was sentenced to be reduced to E-1 and to be confinement for 30 days.

On 15 December 2015, at a General Court-Martial, Sergeant (E-5) Xavier T. Hunter, USAG-Daegu, was found guilty of one specification of Larceny of a value over \$500 and one specification of Larceny of a value under \$500 (Article 121, UCMJ) and one specification of Dereliction of Duty (Article 92). His adjudged sentence was to be confined for fourteen months, to be fined \$7,796.00, and to be discharged from the service with a Bad Conduct Discharge.

Results of ROK Criminal Prosecutions for December 2015

In Suwon District Court, on 3 December 2015, SPC Marcus D. Dickerson, B Co, 304th ESB, USAG Humphreys, was convicted of DUI. His adjudged sentence was a 1,500,000 Won fine.

In Suwon District Court, on 3 December 2015, SSG David H. Baughman, UNC Honor Guard Company, USAG Yongsan, was convicted of a violation of the Act on the Aggravated Punishment of Specific Crimes (Assault upon a Driver Operating Motor Vehicle). His adjudged sentence was imprisonment for 8 months, suspended for 2 years.

In Seoul Central District Court, on 7 December 2015, SGT Nicholas W. Smelser, B Co, 121st CS Hospital, USAG Yongsan, was convicted of Assault. His adjudged sentence was a 1,000,000 Won fine.

In Seoul Central District Court, on 7 December 2015, SPC Andrew S. Atkinson, A Co, 2-2 AHB, K-16, was convicted of traffic law violations. His adjudged sentence was a 1,000,000 Won fine.

In Seoul Central District Court, on 7 December 2015, PVT Jacqueline Martinez, B Co, 121st CS Hospital, USAG Yongsan, was convicted of Obstruction of Performance of Official Duties. Her adjudged sentence was a 3,000,000 Won fine.

In Uijeongbu District Court, on 10 December 2015, CPT Timothy L. Smith, HHB, 8th Army (Ops Co), USAG Yongsan, was convicted of traffic law violations. His adjudged sentence was a 1,500,000 Won fine.
