

Results of US Court-Martials for October 2015

On 9 October 2015, at a General Court-Martial, PVT Marques D. Entzminger, 1st Signal Brigade, Eighth Army, was found guilty of three specifications of Communicating Indecent Language (Article 134, UCMJ), one specification of Communicating a Threat (Article 92), and one specification of Indecent Exposure (Article 120c). He was sentenced to be confined for 16 months and to receive a Bad Conduct Discharge.

On 14 October 2015, at a General Court-Martial, SGT Anthony Patton, 2d Sustainment Brigade, 2d Infantry Division, was found guilty of one specification of Cruelty and Maltreatment (Article 93, UCMJ) and one specification of wrongfully accessing the barracks CCTV (Article 134). He was sentenced to be reprimanded, to forfeit \$1,596.00 of pay for one month, to be reduced to the grade of E-1, and to be discharged from the service with a Bad Conduct Discharge.

On 15 October 2015, at a General Court-Martial, SGT Rinard A. Orage, 2d Combat Aviation Brigade, 2d Infantry Division, was found guilty of one specification of False Official Statement (Article 107, UCMJ) and one specification of Larceny (Article 121). He was sentenced to be reduced to the grade of E-3, to be confined for 7 months, and to be discharged from the service with a Bad Conduct Discharge.

On 22 October 2015, at a Summary Court-Martial, PFC Jeremiah Flavius, 501st Military Intelligence Brigade, Eighth Army, was found guilty of one specification of Abusive Sexual Contact (Article 120, UCMJ). He was sentenced to be reduced to the grade of E-1, to forfeit \$343.00 pay, and to perform hard labor without confinement for 30 days.

On 28 October 2015, at a General Court-Martial, PV2 Hayden Shepard, 210th Field Artillery Brigade, 2d Infantry Division, was found guilty of one specification of Violating a Law General Regulation (Article 92, UCMJ), five specifications of Sexual Assault (Article 120), and one specification of Other Sexual Misconduct (Article 120c). He was sentenced to be reduced to the grade of E-1, to forfeit all pay and allowances, to be confined for 6 years, and to receive a Dishonorable Discharge.

Results of ROK Criminal Prosecutions for October 2015

In Uijeongbu District Court, on 8 October 2015, SPC Jonathan M. Frazier, B Co, 2/9th Infantry, USAG Yongsan, was convicted of leaving the scene of an accident in violation of the Road Traffic Act. His adjudged sentence was a 1,000,000 Won fine.

In Seoul Central District Court, on 14 October 2015, PFC Timothy J. Schoenle, B Co, 719th MI Battalion, USAG Yongsan, was convicted of Fraud and Obstruction of Performance of Official Duties. His adjudged sentence was a 1,500,000 Won fine.

In Seoul Central District Court, on 30 October 2015, PFC Clayton S. Baggett, UNC Honor Guard Company, USAG Yongsan, was found not guilty of the charge of Destruction and Damage of Property.

In Seoul Central District Court, on 30 October 2015, PFC Gregory L. Roman, HHC, 121st CS Hospital, USAG Yongsan, was convicted of Indecent Act by Compulsion. His adjudged sentence was a 2,000,000 Won fine and registration as a sex offender with the local authority.

In Seoul Central District Court, on 30 October 2015, SSG Lawrence J. Eyring, 106th Medical Company (VS), USAG Yongsan, was exonerated of the charge of a violation of the Act on Special Cases Concerning the Settlement of Traffic Accidents when the court dismissed the indictment.
