EFFECTIVE 3 DEC 21

THE ROK WILL IMPOSE A MANDATORY 10-DAY QUARANTINE FOR ALL INTERNATIONAL ARRIVALS REGARDLESS OF VACCINATION STATUS.

AS A STANDARD PRACTICE, USFK WILL STAY ALIGNED WITH THE NEW ROK POLICY AND IMPLEMENT THE FOLLOWING MEASURES:

- MANDATORY 10-DAY QUARANTINE TO ALL USFK-AFFILIATED ARRIVALS REGARDLESS OF VACCINATION STATUS
- NO WORKING QUARANTINE / HEALTH MONITORING STATUS FOR FULLY VACCINATED ARRIVALS
- REQUIRE A QUARANTINE ACTION PLAN (QAP) APPROVED AT THE SQUADRON/BATTALION CDR LEVEL (OR CIVILIAN EQUIVALENT) IF QUARANTINING IN A LOCATION OTHER THAN A USFK-MANAGED QUARANTINE FACILITY
- PCR TESTS ON DAY 1 AND DAY 8/9 PRIOR TO RELEASE
- COHABITANTS HAVE FREEDOM OF MOVEMENT AFTER TRAVELER'S NEGATIVE DAY 1 TEST RESULT
- NON-SOFA AFFILIATED ARRIVALS & SHORT-TERM VISITORS: MAY NOT QUARANTINE IN SOFA-AFFILIATED INDIVIDUAL'S RESIDENCE UNLESS GRANTED AN EXCEPTION TO POLICY (ETP) BY THEIR CHAIN OF COMMAND.
